## VIP Festival D'Ete Experience 2018

### Rules & Regulations

1. No purchase necessary.
2. One prize will be awarded. **The prize includes; Two VIP Section Tickets for Festival d'été de Québec from July 13 – 15, 2018, 2 round trip flights to Quebec City, and 3 nights accommodation at C3 Hotel Art De Vivre courtesy of First Canadian Place. The value of the prize is \$3660 (VIP Tickets x 2 = \$1260, 3 nights hotel accommodation at C3 Hotel Art De Viv \$300 x 3 = \$900, Round trip airplane tickets to Quebec = approx. \$1500).** The prize is referred to as the "Prize" in the rules and regulations.
